- 8. UNFINISHED BUSINESS**
  1. Appropriation #1, BE IT THEREFORE ENACTED that the amount of \$100.00 from the College of Sciences and \$100.00 from the General Fund be appropriated to the UL Wakeboard Club to alleviate the cost of 8 students attending the Southern Regional Qualifying to be held in Austin, Texas from October 12<sup>th</sup>—October 14<sup>th</sup>.
  2. Appropriation #2, BE IT THEREFORE ENACTED that the amount of \$100 from Graduate School, \$100 from the College of Sciences, and \$50 from the General Fund be appropriated to Heather Bracken to defer the cost of attending the Mid-Year Crustacean Society Meeting in Coquimbo, Chile from October 14<sup>th</sup> until October 17<sup>th</sup>, 2007
