 1. Appropriation #1, BE IT THEREFORE ENACTED that the amount of \$100.00 from the College of Sciences and \$100.00 from the General Fund be appropriated to the UL Wakeboard Club to alleviate the cost of 38 students attending the Southern Regional Qualifying to be held in Austin, Texas from October 12th—October 14th.

2. Appropriation #2, BE IT THEREFORE ENACTED that the amount of \$100 from Graduate School, \$100 from the College of Sciences, and \$50 from the General Fund be appropriated to Heather Bracken to defer the cost of attending the Mid-Year Crustacean Society Meeting in Coquimbo, Chile from October 14th until October 17th, 2007.
3. Amendment # 1, BE IT THEREFORE AMENDED that section 5c under the Rules Governing Campaigning be deleted and replaced with:
 - c. Other Electronic Media
 - i. Mass messaging with the use of cell phone and email accounts is prohibited.
 - ii. Purchasing ads on websites, such as Facebook, are prohibited.
 - iii. The use of messaging, creation of party/individual groups, and party/individual websites are permitted.
 - iv. Slanderous and/or libelous acts committed online are prohibited.
 - v. Any candidate will be able to file grievances, in the same fashion as other grievances, to the judicial branch for review; printing the paper with the grievance for review will be appropriate form for the candidate filing the grievance.
4. Amendment #2, BE IT THEREFORE AMENDED THAT, Section 2: committees, part 2 section a. under The Legislature be amended to read as stated on form.
Also, BE IT THEREFORE AMENDED THAT Section 3: Standing Committees under The Legislature be renumbered to read as stated on form.
